III. BUSINESS

A. The RP Group and SSCCC Partnership

Darla Cooper, Executive Director, The Research and Planning Group, informed members that representatives from the RP Group and the SSCCC have maintained an ongoing partnership, attending each other's board meetings and collaborating on various initiatives such as transfer resources, student videos, and research advisory committees. At the September SSCCC meeting, two new collaboration opportunities were identified: improving student leaders' access to institutional research on their campuses and integrating student-facing resources into future RP Group research projects. Dr. Cooper presented a request to form three task forces with SSCCC membership: 1) increasing college student leaders' access to local IRPE offices; 2) adding student-facing resources as a regular part of The RP Group's research projects; and 3) creating research opportunities specifically for CCC students. President Reyes asked for volunteers to serve on the three groups:

- 1) increasing college student leaders' access to local IRPE offices: LAD VIII Flores-Olson, LAD VI Landeros, VPRA Jarvis, and VPF Demaestri
- 2) adding student-facing resources as a regular part of The RP Group's research projects:

RAD X Hernandez, LAD VII Varkey, RAD III Malbrough, and RAD IX Pamphile.

3) creating research opportunities specifically for CCC students. RAD II Hill, VPC Maskey, LAD IX Jackson, and RAD VI Rivera.

Motioned, seconded (VPRA Jarvis) to approve the SSCCC membership for the three RP Task Forces as discussed.

B. AB 1705 Research)

Alyssa Nguyen, Senior Director of Research for the Research and Planning Group, presented statewide research on AB 705 and AB 1705, focusing on student access and completion in transfer-level math and English. The presentation highlighted the historic challenges of extended course sequences and inequitable placement practices, particularly affecting female, African American/Black, and Hispanic students who often self-placed into lower-level math courses.

Since implementation, significant progress has been made with nearly all students now having access to transfer-level courses and notable increases in one-year math completion rates across all student groups.

Between 2015–16 and 2023–24, completion rates rose 3.8 times for Black students, 3.2 times for Hispanic/Latine students, 2.2 times for Asian students, and 1.6 times for White students.

Ms. Nguyen emphasized the need to continue dismantling institutional and classroom barriers, redesign support structures, and reimagine preparation for required math courses to ensure equity and success for all students. Her presentation can be found at this link.

Alisha Nagpal, Vice President of Legislative Affairs, and Mikala Hutchinson, Legislative Specialist, updated on legislative activities.

F. Executive Director Recruitment Process

Executive Director Dr. Adams presented a proposed Executive Director Search process, outlining a transparent and inclusive process to guide the Board through the hiring of the next Executive Director. She is recommending hiring a consultant who will assist in planning, recruitment, interviews, and onboarding to ensure continuity and alignment with best practices. The proposed timeline spans January through December 2026, with the new Executive Director anticipated to begin by the end of that year.

The proposal acknowledges the importance of maintaining continuity during leadership transitions, particularly given annual Board turnover, and emphasizes clear documentation, consistent communication, and consultant advice as key strategies. The current Executive Director will serve in an advisory capacity during planning but will not participate in recruitment or selection phases.

Motioned, seconded (VP Chandler) to approve the proposal as presented with the understanding that it will receive further feedback from the grantor and consultant. No objections, motion passed.

This item will return to a future meeting if revised.
